Harbor By Laws \_ Section 2(a) (i): An approved mooring permit from the Harbormaster is required for the installation of mooring tackle for any boat, float, or lobster car/pound within the limits of Cohasset Harbor. The application for such permit shall be prescribed by the Selectman on a form entitled "Application for Mooring Location" dated April 1985 as revised from time to time.
